
Conditions for granting the No AI Declaration™ mark – Category No. 15: Spiritual and Religious Content

Version 1.1 | effective from: 16.07.2025

1. General introduction

No AI Declaration™ is a public statement by an individual or a company that in a given area of activity no artificial intelligence (AI) tools are used.

The declaration is public, open and entered into the No AI Movement™ register. Each granted declaration receives a unique identification number and is cryptographically anchored (hash) in a selected blockchain network, which enables independent confirmation of its integrity and date of issuance (details in the No AI Movement™ technical specification).

The category "Spiritual and Religious Content" covers materials created for spiritual, religious or philosophical purposes, including sermons, teachings, meditations, prayers, reflections, commentaries, as well as other content intended to support spiritual development or convey religious teachings.

2. Definitions

• Artificial intelligence (AI)

Solutions using machine learning or generative models (e.g. LLM, TTS, NLU/NLP) capable of automatically creating, transforming or analyzing content.

• Spiritual and religious content

Sermons, prayers, meditations, reflections, teachings and other materials related to religion, spirituality or inner practices, created to convey values, teachings or experiences.

3. General rules for the category “Spiritual and Religious Content”

The right to use the No AI Declaration™ mark may only be granted to entities that:

- create spiritual and religious content independently, exclusively by humans,
- do not use AI tools in the process of preparing, writing, delivering or publishing content,
- ensure that the message maintains authenticity resulting from human experience and reflection.

The declarant undertakes that:

- he/she understands what the use of AI means in the context of spiritual and religious content,
- no generative AI tools are used to create, modify or analyze content,
- he/she has read this document and accepts its conditions,
- he/she takes full responsibility for the compliance of the declaration with the factual state.

4. Typical applications of AI in spiritual and religious content (not permitted)

No AI Declaration™ excludes, among others:

- generating sermons, homilies, meditations, prayers or commentaries with language models,
- automatic translation of spiritual and religious content using AI (if it constitutes the main form of the message),
- AI voice synthesis used to deliver sermons, prayers or meditation recordings,
- automatic creation of graphics, images or multimedia with religious/spiritual character,
- analysis and personalization of spiritual content based on user data by AI.

Clause: the above list is illustrative and not exhaustive. The ban applies to all AI solutions performing equivalent functions, regardless of the trade name.

5. Permitted uses of AI – applicable in all categories

AI may be used in areas that do not affect the content, form or performance of the work covered by the declaration.

Permitted uses include:

- education and self-learning (e.g. studying theory, history, techniques and concepts related to the given field of creativity and activity),
- information search and inspiration (e.g. obtaining source data, supporting materials, examples, comparisons, trends),
- organizational and technical support (e.g. work planning, file management, provided it does not affect the content of the work/service),
- system and technological support (e.g. user interface handling, error detection, application translation, technical AI assistance in managing the work environment).

6. Permitted uses of AI – Category: Spiritual and Religious Content

AI may only be used in technical or organizational activities that do not affect the content, form or meaning of spiritual or religious messages. In particular, the following are permitted:

- organizing materials (e.g. cataloguing sermons, archiving recordings),
- automatic assignment of numbers, tags or publication dates,
- generating collective statistical reports (e.g. number of plays of recordings) – without content analysis,
- using tools, including AI-based ones, solely to check language correctness (spelling, punctuation, basic grammar) – it is not permitted to use AI to change the content, style, tone or meaning of the message.

7. Final remarks

Spiritual and religious content must reflect authentic human experience and message. AI cannot be used to create or modify them – only organizational and language support of a technical nature is permitted.

8. Conditions for obtaining the right to use the No AI Declaration™ mark

To obtain the right to use the No AI Declaration™ mark in the category "Spiritual and Religious Content", the following conditions must be met:

- all spiritual and religious content (written, oral, audiovisual) is created exclusively by humans,
- no element of the message is generated or supported by an AI system,
- AI speech synthesis systems are not used to deliver spiritual and religious content,
- the declarant can describe the process of creation and confirm the authenticity of the content,
- the No AI Declaration™ mark must not be used in connection with activities containing AI elements in the spiritual or religious message.

No AI Movement™ may define the validity period of the declaration and the procedure for its renewal, including requirements for updating statements and possible administrative fees.

9. Procedure for obtaining the right to use the No AI Declaration™ mark

- familiarization with this document,
- completion of the online form,
- submission of a statement of compliance with the conditions,
- receipt of the declaration number and PDF document,
- entry into the public register of No AI Movement™ declarations.

10. Rules for the use of the No AI Declaration™ mark

- The mark must be used in its original form, with protective space; it must not be combined with other marks into a composite mark.
- The digital version of the mark should link to the entry in the public register of declarations.
- It is forbidden to suggest that No AI Declaration™ is an official or governmental certificate.

11. Control and responsibility

Declarations may be verified randomly or in the event of:

- reported suspicion of abuse,
- public violation of the rules,
- changes in the way the activity covered by the given category is conducted.

In case of violation:

- in minor cases No AI Movement™ may apply a warning and corrective period (7–14 days),
- in case of material or repeated violation the declaration may be suspended or revoked with immediate effect,
- the declarant has the right to appeal within 14 days; the appeal is examined by the No AI Movement™ verification team.

The declarant undertakes to inform the organizer of any significant changes and to cooperate during any possible control.
